

AN ORDINANCE PROVIDING FOR THE DISPLAY, SALE AND DISCHARGE OF FIRE WORKS AND OTHER EXPLOSIVES, AND PROVIDING A PENALTY FOR THE VIOLATION THEREOF.

BE IT ORDAINED BY THE BOARD OF ALDERMEN OF THE CITY OF WAVERLY, MISSOURI, AS FOLLOWS:

SECTION 1: Ordinance No.1935 is herewith repealed.

SECTION 2: From and after the date of the passage and approval of this Ordinance, it shall be unlawful for any person, firm or corporation doing business within the City, to sell, offer for sale, expose for sale, use, discharge or explode any blank cartridge toy pistol, toy cannon, or cane in which explosives are used, firecrackers, torpedo, skyrockets, roman candles, salutes, bombs, sparklers, torches or displays or other fireworks of any kind whatsoever, except that the same may be sold one week prior to the 4th of July of each year, and the same may be discharged on the 4th day of July, between the hours of eight o'clock a.m. and eleven o'clock p.m. of each year only; provided, that the same may not be shot or discharged at any time in the area from Broad Street to Kelling Avenue to Kelling Avenue to East Washington Street and East Washington Street from Walnut Street or Highway No. 24 to Kelling Avenue.

SECTION 3: The provisions hereof shall not apply in the event of a sale of fireworks for pyrotechnic display to fair associations, amusement parks or civic organizations, provided, however, that such organizations shall secure permit from the Mayor of the City authorizing the purchase and display of fireworks at the location specified in the permit.

SECTION 4: No person, at any time, shall while riding in a motor vehicle, discharge any of the fireworks or other explosives described in this Ordinance.

SECTION 5: Further, it shall be unlawful, at any and all times, for any person, firm, partnership, group or corporation, individually or collectively, in whole or in part, doing business within this City or not doing business, to have, possess, sell, offer for sale, expose for sale, use, discharge or explode any bottle rocket or other explosive device generally designed as being such powder charge attached to a stick, although it may be any form of bottle rocket.

SECTION 6: Any person violating the provisions of this Ordinance shall, upon conviction, be deemed guilty of a misdemeanor, and fined not less than Ten or more than One Hundred Dollars.

SECTION 7: This Ordinance shall be in full force and effect from and after the date of its passage by the Board of Aldermen and approval by the Mayor.
